Clients can easily schedule appointments at their convenience, allowing assigned personal managers to efficiently handle every detail of the relocation process.

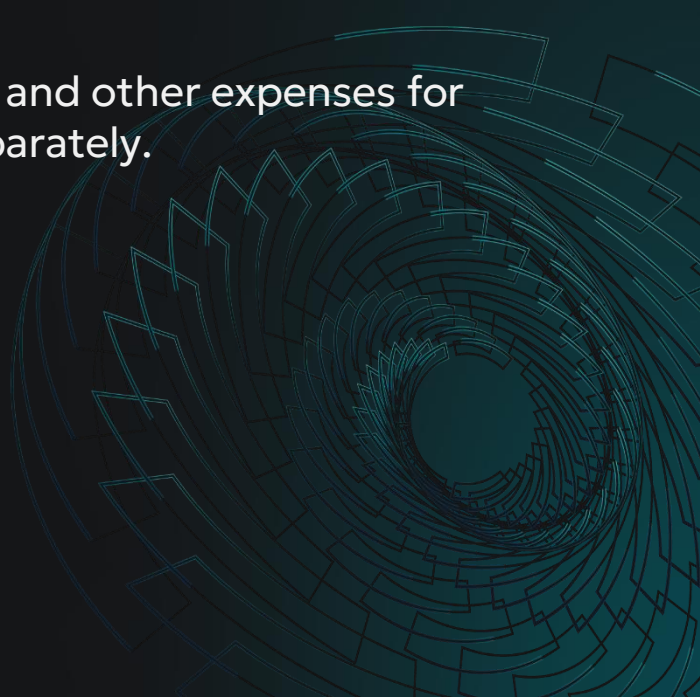
