*\* Notification on arrival of foreign citizens should be sent during 3 business days of entry of foreign national (should be submitted for all foreign nationals ,not depending on purpose of travel and conditions of visa regime) to Authorized Government Body by host Party (for those individuals who are travelling with tourism purposes, notification should be sent by hotel or owner of property where foreign citizen is residing).*

***Please keep in mind, that not timely submission of notification will lead to administrative prosecution under the Administrative Code of the Republic of Kazakhstan.***

*\*In accordance with the article 6 of the national law On Migration, nationals of the above-mentioned countries can enter and stay in Kazakhstan for a period up to 30 calendar days at each entry, but not exceeding 90 calendar days cumulatively within 180 calendar days.*

*\* Visa -free regime is eligible only for short-term business and tourism purposes. **Work with visa-free entry regime is prohibited.***

**\*\* Registration of foreign employees and experts, who have arrived from countries that have ratified international treaties with Kazakhstan on visa-free regime is carried out for a period during which visa-free stay is allowed. Registration is carried out for the duration of the employment labor contract or expert agreement for the performance of work (provision of services).**
